#### 10 10.1 HIGHWAYS & TRANSPORTATION MATTERS:

- (a) REPAIR OF SIGNS & POTHOLES Councillors, once again, discussed the dreadful condition of the roads throughout the Parish with particular reference to Warsill and the dip in the road near the Drover's Crossroads, Bishop Thornton. The meeting agreed there was little point in writing to NYCC about the matter due to the principles underpinning the Councils road repairs policy as previously articulated by County Cllr Mr M Harrison. (UNANIMOUS DECISION)
- (b) NEW NATIONAL CYCLE NETWORK (NCN 67): Councillors discussed the proposed route of the New National Cycle Network (NCN 67), voicing concern about the cyclist safety at the Drover's Crossroads and on Westerns Lane, Markington but agreed not to make any comments on the matter in view of County Cllr Mr M Harrison's assurance that this was the cyclists preferred route. (UNANIMOUS DECISION)
