 COLLAPSED FOOTPATH, GRANGE CLOSE, SHAW MILLS: Cllr Mr Baker read an e-mail from NYCC's Area 6 Highways apologising for the delayed response, the problem being first brought to NYCC's notice in October 2013 and stating that the matter would be rectified within two weeks of the date on the e-mail that being 10th October. The Clerk stated that a copy of the e-mail had been forwarded to Mrs Rickards and that she had subsequently reported that the work had been carried out.
 - GIVE-WAY SIGN MARKINGTON SIDE OF DROVERS CROSSROADS:
 The Clerk informed the meeting that the damage to the Give-Way Sign on the
 Markington side of the Drover's Crossroads had been reported to NYCC's Area
 6 Highways. The Clerk reported that NYCC had since put a temporary
 Give-Way sign in place and placed an order with the contractors to reinstate the
 permanent Give-Way sign.
